Meeting Detail-

As per the prevalent practice, President presided over the meeting and extending warm welcome to all the members who have joined the meeting

President briefed the members on election process. He explained, as per the Rules and Regulation of IVC, under section 13.1.3, tenure of Managing Committee & Office Bearers shall be from 1st April to 31st March.

Also, under section 13.1.4. The tenure of office of the President, Vice President, Honorary Secretary, and Honorary Treasurer shall be for two years. They are eligible to be re-elected.

Hence, the term of Current

will be completing their tenure by 31st March 2026

Election process for the vacant posts initiated as per the IVC rules and Regulations under section 32.0. On the 3rd MC meeting held on 23rd February 2026, the election date was decided for 27th March 2026 and invited the nominations for the above posts on or before 12th March 2024 before 5 pm.

On the cutoff date, only one nomination was received for the post of President. Also, only one nomination was received for the posts of Vice President, Honorary Secretary, Honorary Treasurer.

Hence, as per the Rules and Regulation of IVC under section 32.3, since, no other nomination for the post of president, the nominated privilege member **Dr. Shreekant Diwan, declared Elected as the PRESIDENT** of Indian Vinyl Council for the period of 2 years from 1st April 2026 till 31 st March 2028.

Also, the nominated privilege member **Mr. Rajeev Mehendale, declared Elected as Vice President, Mr. Sanjay Nawander, declared Elected as Honorary Secretary and Mr. Pijush Barman declared Elected as Honorary Treasurer** of Indian Vinyl Council for the period of 2 years from 1stApril 2026 till 31st March 2028.

After detailed discussion, the MC members present in the meeting agreed to the proposal of the Office Bearers and requested the President to table for the following resolution:

Since there were no 2nd nomination for the post of Vice President, Mr. Rajeev Mehendale declared Elected as the Vice President of Indian Vinyl Council.

Since there were no 2nd nomination for the post of Honorary Secretary, Mr. Sanjay Nawander declared Elected as the Honorary Secretary of Indian Vinyl Council.

Since there were no 2nd nomination for the post of Honorary Treasurer, Mr. Pijush Barman declared Elected as the Honorary Treasurer of Indian Vinyl Council.

All the above post are for the period of 2 years from 1st April 2026 till 31st March 2028

Resoled that the subject of Election as discussed and / expressed to the Management Committee and they are hereby approved and adopted
